Subject: Reorganization/Restructuring of Public Works (R&B) Department- Drawal of Salary thereof.

**Government Order No. 29 -PW(R&B) of 2024
Dated: 30 .01.2024**

Whereas vide Govt Order No. 22-JK(GAD) of 2023 dated 06.01.2023, Public Works (R&B) department was reorganized/restructured with merging / subsuming the Engineering wings of 10 other departments including engineering wing of SKIMS, Soura; and

Whereas, vide Govt Order No. 319-PW(R&B) of 2023 dated 02.08.2023, all the engineering/non engineering staff of subsumed engineering wings of other departments were relieved from their respective departments and directed to report in the office of Development Commissioner (works)/Engineer in chief, J&K; and

Whereas vide Govt Order No. 345-PW(R&B) of 2023 dated 18.08.2023, all the engineering staff of subsumed engineering wings of SKIMS Soura, SKIMS Bemina and Estates department were directed to report to respective Executive Engineers viz R&B Division Soura, R&B Division Bemina, Projects Division-3rd Srinagar and Projects Division-3rd Jammu respectively. These posts have already been reflected in the other units/pool of the reorganized structure of the department; and

Whereas, the Executive Engineers of R&B Division Soura, R&B Division Bemina and Projects Division-3rd Srinagar/Jammu has intimated that in absence of sanction of these posts at divisional level, the respective DDOs are unable to draw salaries in favour of these employees, who have been retained in these divisions as these posts were not reflected in the office structure of Division issued vide Govt order No. 22-JK(GAD) of 2023 dated 06.01.2023.

Now, therefore, in view of the above and for the purpose of drawal of salaries, sanction is hereby accorded to:-
