Whereas, on the basis of the recommendations of the J&K Services Selection Board vide communication No. JKSSB-PLAN/25/2022-03 dated 03.03.2023, recommended the selection of Shri Sewa Singh S/o Shri Romesh Singh R/o Ladha Talab, Udampur for the post of Junior Assistant in the Public Works (R&B) Department; and

Whereas, subsequently vide Notice issued under endorsement No. PWD-NGAZ0CIV/60/2023-05 (7145499) dated 20.03.2023 the candidate was advised to submit his Email Address and Mobile Number for registration under Employee Verification System (EVS); and

Whereas, after receipt of the credentials of the candidate the same were forwarded to the Criminal Investigation Department online through EVS Portal vide Form No. 59606 for obtaining his Character and Antecedents report; and

Whereas, on the basis of report furnished by the Criminal Investigation Department, J&K, among others, Shri Sewa Singh S/o Romesh Singh R/o Ladha Talab, Udampur was appointed as Junior Assistant vide Government Order No. 251-PW(R&B) of 2023 dated 13.06.2023 issued under endorsement No. PWD-NGAZ0CIV/60/2023-05 (7145499) dated 13.06.2023 and his services were placed at the disposal of Chief Engineer, PMGSY (JKRRDA) Jammu for further adjustment; and

Whereas, the candidate was directed to report to the office of the Chief Engineer, PMGSY (JKRRDA) Jammu within a period of twenty one (21) days from the date of issuance of appointment order; and

Whereas, among other conditions, it was also stipulated that if the candidate fails to join within stipulated period, his appointment shall be deemed to have been cancelled ab-initio without any notice; and

Whereas, the Chief Engineer, PMGSY (JKRRDA) vide communication No. CEJ/PMGSY/7220-22 dated 08.07.2023 intimated that Shri Sewa Singh S/o Shri Romesh Singh R/o Ladha Talab, Udhampur, appointed as Junior Assistant falling at S.No. 18 and placed at the disposal of Chief Engineer, PMGSY, Jammu for further adjustment vide Government Order No. 251-PW(R&B) of 2023 dated 13.06.2023 and further adjusted/posted in the office of Executive Engineer, PMGSY Division Kishtwar vide his office order No. CEJ/PMGSY/71 of 2023 dated 13.06.2023, has neither joined in his office nor in the office of Executive Engineer, PMGSY Division Kishtwar within the stipulated time as intimated by Executive Engineer, PMGSY Division Kishtwar vide his letter No. PMGSY/K/2398-99 dated 06.07.2023.

In view of the above, it is ordered that the appointment of Shri Sewa Singh S/o Romesh Singh R/o Ladha Talab, Udhampur as Junior Assistant in the Public Works (R&B) Department pursuant to Government Order No. 251-PW(R&B) of 2023 dated 13.06.2023 is hereby cancelled ab-initio.
