Whereas, on the recommendations of the Services Selection Board, J&K conveyed vide No. SSB/Secy/Sel/Class-IV/2021/6273-78 dated 18.10.2022 and the General Administration Department's O.M.No. GAD/MTGRDIV/267/2022-09-GAD dated 27.10.2022, among others, Shri Chander Parkash Singh(MTS) got appointed as Class IV (MTS) vide Government order No. 386-PW(R&B) of 2022 dated 29.10.2021 ; and

Whereas, vide Government order No. 386-PW(R&B) of 2022 dated 29.10.2022, among others, the services of Shri Chander Parkash Singh(MTS) were placed at the disposal of the Chief Engineer, PMGSY(JKRRDA) Jammu for further posting and joined the concerned office on 07.11.2022; and

Whereas, subsequent to his appointment/joining, the Chief Engineer, PMGSY(JKRRDA), Jammu vide his letter No. CEJ/PMGSY/2023-24/5160-62 dated: 20.06.2023 has informed that Shri Chander Parkash Singh(MTS), through the medium of an application dated 09-06-2023 has tendered his resignation from the post of Class-IV (MTS); and

Whereas, the Chief Engineer, PMGSY(JKRRDA), Jammu forwarded his request to the Administrative Department PW(R&B) for acceptance of his resignation as the said candidate has been selected Assistant cum Typist in SKUAST, Srinagar; and

Whereas, the matter has been examined/considered with reference to the rules governing the subject in the department and it has been observed that the concerned official is still on probation and has not qualified the prescribed probation period of service.

Whereas, Rule 21(1) of J&K Civil Services (Classification, Control & Appeal) Rules, 1956, provides as under:-

"At any time before the expiry of prescribed period of probation the appointing authority may:

- a) suspend the probation of a probationer and discharge him from the service for want of vacancy; and**
- b) at its discretion terminate the probation of a probationer and discharge him from the service."**

Now, therefore, in exercise of the powers conferred under Rule 21(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by Shri Chander Parkash Singh(MTS) is hereby accepted and is discharged from the Government service w.e.f. 09.06.2023 on his own request.


