Subject: Transfer of tracks leading to Shri Amarnathji Holy Cave.

**Government Order No. 304 -PW(R&B) of 2022
Date: 05 .09.2022**

Sanction is hereby accorded to the transfer of following tracks leading to Shri Amarnathji Holy Cave from Chandanwari and Baltal axis to Border Roads Organization (BRO) for development, maintenance and management of Yatra tracks:

- i. Chandanwari-Sheeshnag-Panjtarni-Holy Cave track.
- ii. Baltal-Holy Cave track.

Sanction is also accorded to the transfer of Ranga to Baltal road including Nilgrath to Y-Junction to BRO for development and maintenance.

Transfer of above tracks and roads is subject to the following conditions:

1. Statutory clearances, if in case it is required at any stage in the forest area, shall be obtained by BRO.
2. The Supreme Court decisions and other courts directions issued from time to time shall be implemented in letter and spirit and subject to any petition pending in the Court of Law.
3. All the project reports and work proposals shall be got approved from High Level Coordination Committee of Shri Amarnathji Shrine Board for its execution. Resource related issues shall also be placed in the Committee for its due redressal.
4. Above arrangement for development and maintenance of Yatra tracks shall not disturb the ongoing NH-501 works of development and DPR preparation undertaken by Ministry of Road Transport and Highways (MoRTH), Government of India.
5. All contracts of PW(R&B) Department and Tourism Department shall be completed by October 2022 and all liabilities related to development of tracks to be cleared by March 2023.
