**Subject: Providing of Budgetary Support to JKPCC Ltd. to meet its Salary Demand.**

Govt. Order No.: 310 -PW (R&B) of 2023  
Dated: 28 -07-2023.

Sanction is hereby accorded to the release and advance drawl of funds by the Director Finance PW (R&B) Department to the tune of Rs. 12,38,00,000 (Rupees Twelve Crore Thirty Eight Lakh only) released by the Finance Department vide E UO No. FD-BDGT0 -16/13/2021-03 (CC 19796) dated 27-07-2023 for further placement with MD, JKPCC Ltd. for drawl of 2-month salaries of employees.

The funds so authorized are subject to the following conditions:

- i. Funds shall be utilized for meeting salary only.
- ii. There shall be no diversion of funds.
- iii. The salary should be disbursed after due scrutiny ensuring that no salary is disbursed to employees against whom any disciplinary proceedings are pending.
- iv. The next installment shall be released only after details sought vide UO dated 11-07-2023 are provided after due reconciliation.
- v. Financial Controller JKPCC shall vouch safe the expenditure.
- vi. Expenditure shall be incurred after fulfilling of all codal formalities.
- vii. Utilization certificate duly signed by MD, JKPCC be submitted to Administrative Department.
- viii. Unutilized funds shall be returned to the Finance Department along with the interest.

The Expenditure on this account shall be debited to the detailed account head given as under:

2. Major Head : 3054 Roads and Bridges
3. Sub Major Head : 80 General
4. Minor Head : 001 Direction and Administration
5. Group Head : 0099 General
6. Sub Head : 6033 Merger of JKPCC with PWD
