Whereas, on the recommendations of the Service Selection Board, J&K conveyed vide No. SSB/Sel/Secy/UT/03/2022/5684-89 dated 04.08.2022 & No. JKSSB-ADM/134/2023-03 dated 15.05.2023, among others, Mr. Owais Ahmad Beig S/o Manzoor Ahmad Beig R/o Tehsil Kokernag, District Anantnag was appointed as Junior Engineer vide Govt Order No. 365-PW(R&B) of 2023 dated 01.09.2023; and

Whereas, among others, the services of Mr. Owais Ahmad Beig, Junior Engineer was placed at the disposal of the Chief Engineer, PW(R&B) Department Kashmir for further posting and post reorganization was posted in the office of Chief Engineer PW(R&B) South Kashmir; and

Whereas, after his appointment/ joining, the Chief Engineer PW(R&B) South Kashmir vide communication No. CE/R&B/SK/ADM/1330-31 dated: 09/05/2024 has intimated that Mr. Owais Ahmad Beig has tendered his resignation from Government Services through an application dated: 20.03.2024; and

Whereas, the matter has been examined/considered as per the rules governing the subject and it has been observed that the concerned official was still on probation and has not qualified the prescribed probation period of service;

Whereas, Rule 21(1) of J&K Civil Services (Classification, Control & Appeal), Rules, 1956, provides as under:-

"At any time before the expiry of prescribed period of probation the appointing authority may:

- a. suspend the probation of a probationer and discharge him from the service for want of vacancy; and
- b. at its discretion terminate the probation of a probationer and discharge him from the service."

NOW THEREFORE, in terms of Rule 21(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the probation of Mr. Owais Ahmad Beig, Junior Engineer (Civil) is hereby terminated and is discharged from Government Services with effect from 01.01.2024 on his own request.
