Whereas, on the recommendations of the Services Selection Board, J&K conveyed vide No. SSB/Secy/Sel/Class- IV/2021/6273-78 dated 18.10.2022 duly endorsed by the General Administration Department vide O.M. No. GAD/MTGRDIV/267/2022- 09-GAD dated 27.10.2022, among others, Mr. Sajan Sharma MTS of (R&B) was appointed as Class IV (MTS) vide Government order No.386-PW(R&B) of 2022 dated 29.10.2022 ; and

Whereas, vide Government order No. 386-PW(R&B) of 2022 dated 29.10.2022, among others, the services of Mr. Sajan Sharma MTS were placed at the disposal of the Chief Engineer, PW(R&B) Kashmir for further posting, who had joined there on 07/11/2022; and

Whereas, subsequent to his appointment/ joining, the Chief Engineer, PW(R&B) Kashmir vide letter No. CE/RBK/ADM/8705- 07 dated: 08.07.2023 has reported that Mr. Sajan Sharma MTS has tendered resignation from the post of Class-IV (MTS) through the medium of an application dated 01/06/2023 ; and

Whereas, the Chief Engineer, PW(R&B) Department forwarded his request to this department for acceptance of his resignation as the said candidate has been selected as Constable in Jammu and Kashmir Police (Border Battalion);

Whereas, the matter has been examined/ considered with reference to the rules governing the subject and it has been observed that the concerned official is still on probation and has not qualified the prescribed probation period of service.

Whereas, Rule 21(1) of J&K Civil Services (Classification, Control & Appeal), Rules, 1956, provides as under:-

"At any time before the expiry of prescribed period of probation the appointing authority may:-

- a. suspend the probation of a probationer and discharge him from the service for want of vacancy; and
- b. at its discretion terminate the probation of a probationer and discharge him from the service".

Now, therefore, in exercise of the powers conferred under Rule 21(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by Mr. Sajjan Sharma, MTS is hereby accepted and is discharged from the Government service w.e.f. 01.06.2023 on his own request.
