WHEREAS, on the recommendations of the Services Selection Board, J&K, among others, Mr. Mohd Nasir was appointed as Class IV (MTS), vide Government Order No. 386-PW(R&B) of 2022 dated 29.10.2022; and

WHEREAS, vide Government Order No. 386-PW(R&B) of 2022 dated 29.10.2022, among others, the services of Mr. Mohd Nasir (MTS), Road worker were placed at the disposal of the Chief Engineer, PW(R&B) Department, Zone Jammu for further posting; and

WHEREAS, subsequent to his appointment and joining, the Chief Engineer, PW(R&B) Department, Zone Jammu vide his letter No. CEJ/ESTAB/S/644-46 dated: 20/08/2024 informed that Sh. Mohd Nasir, Orderly, Road worker, through the medium of an application has tendered resignation from the post of Class-IV (MTS) w.e.f 11.09.2023; and

WHEREAS, the Chief Engineer, PW(R&B) Department, Zone Jammu has recommended the case of Sh. Mohd Nasir, Orderly, Road Worker for acceptance of his resignation on the grounds that the said candidate has been appointed as Junior Assistant in Higher Education Department vide Government Order No. 239-JK(HE) of 2023 dated 05.09.2023; and

WHEREAS, the matter has been examined/considered with reference to the rules governing the subject and it has been observed that the concerned official is still on probation and has not qualified the prescribed probation period of service; and

WHEREAS, Rule 21(1) of J&K Civil Services (Classification, Control & ppeal), Rules, 1956, provides as under:-

"At any time before the expiry of prescribed period of probation the appointing authority may:

- a. suspend the probation of a probationer and discharge him from the service for want of vacancy; and
- at its discretion terminate the probation of a probationer and discharge him from the service.

NOW, THEREFORE, in terms of Rule 21(1)(b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the probation of Mr. Mohd Nasir, MTS (Road Worker) is hereby terminated and is discharged from Government Service w.e.f. 11.09.2023 on his own request.
