Subject: Medical Re-imburement claim of Mr. Baint Singh, Ex. Roller Operator.

In terms of Rule 6 of the J&K Civil Service (Medical Attendance & Allowance) Rules, 1990, post facto sanction is hereby accorded to the Medical Reimbursement of medical expenses incurred by Sh. Baint Singh, Ex Roller Operator of Mechanical Division, MED, Anantnag on treatment of his spouse namely, Smt. Rani Kour, at PGI Chandigarh, subjected to the following conditions:

- I. Reimbursement of charges shall be restricted to items/procedures admissible under rules, for the period of hospitalization and cost thereof shall be restricted to the extent of rates applicable to such items/procedures at PGI Chandigarh. Reimbursement of the claim is further subjected to expenditure incurred beyond the package cost admissible under AB-PMJAY SEHAT insurance scheme applicable at the time of treatment.
- II. The reimbursement shall also be regulated as per the circular instructions of Finance Department issued vide FD-code /63/2021-734 dated 31/08/2021.
- III. All relevant medical bills/vouchers shall be verified from relevant medical authority of the hospital where from treatment has been taken.
- IV. Certificate from the competent medical authority (Director Health services/Principal GMC/other) is obtained to certify that drugs and services charged are reasonable and to establish genuineness of the treatment availed in the said hospital.
- V. The DDO shall satisfy himself fulfilment of all the conditions and codal formalities.
- VI. Follows up(s), if any are regulated under rules.
