The appointee(s) shall be allowed to join after production of the following certificates/ documents (in original) to be verified separately:-

- 1. Academic/ Technical Qualification Certificates issued by recognized Institute/ University.
- 2. Matriculation/ Date of Birth Certificate issued by a recognized Educational Board.
- Domicile Certificate issued by the competent authority.
- 4. Health Certificate from the concerned Chief Medical Officer of the District.
- 5. Valid relevant Category Certificate issued by the competent authority, if any applicable.

- The appointment of the candidates shall further be subject to the following conditions:-
- i. The appointee(s) shall furnish an undertaking in the shape of a n affidavit to the effect that the appointee has no criminal record and is not facing any criminal proceedings in any Court of law.
- ii. The appointee(s) shall furnish an undertaking in the shape of an affidavit to the effect that if on verification, his/ her Qualification/Date of Birth/ Reserved Category Certificates from the concerned issuing authorities are found fake/ forged, their appointment shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him/ her.
- iii. That if the candidates has taken loan for self employment from DIC/ Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the domicile District, he/ she shall relinquish the proprietorship of unit/ enterprise before joining the Government service. The appointees shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/ her salary. The DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/ enterprise and recovery to be made and also personally monitor its recovery.
- iv. The salary of the appointee(s) shall not be drawn and disbursed to them unless satisfactory reports in respect of the genuineness of Qualification/ Date of Birth/ Relevant Category Certificate are received from the concerned issuing authority.
- v. The appointee(s) shall be on probation for a period of two years and their probation shall be regulated in terms of the provisions of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956.
- vi. The appointment of the candidates shall be governed by the "New Pension Scheme" as notified vide SRO 400 dated 24.12.2009.
- vii. The inter-se-seniority of the appointee(s) shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- viii. The appointment of the above candidates shall be subject to outcome of writ petition(s), if any, pending before any Competent Court of law.
