Subject: Appointment of candidate for the post of Junior Assistant/Cashier Clerk/Store Attendant/Cadrex Clerk/Computer-Cum-Junior Assistant/ Welfare Organizer.

On the recommendation of the J&K Service Selection Board, sanction is hereby accorded to the appointment of Mr. Irfan Ahmad Wani S/o Gulzar Ahmad Wani R/o H. No. 307, Dar Mohalla, Watalbagh, Lar Ganderbal (RBA) against the post of Junior Assistant in Pay Level-4 (25500-81000) in Divisional Cadre Kashmir in the Public Works (R&B) Department.

The appointee shall report in the Office of Chief Engineer, PW (R&B) Central, Kashmir within a period of twenty one (21) days from the date of issuance of this order failing which he shall forego his right to appointment and the same shall be deemed to have been cancelled ab- initio without any further notice.

The appointee shall be allowed to join only on the production of the following certificates/ documents (in original) to be verified separately:-

1. Academic/ Qualification Certificates issued by recognized Institute/University.
2. Matriculation/ Date of Birth Certificate issued by a recognized Education Board.
3. Domicile Certificate issued by the competent authority.
4. Health Certificate from the concerned Chief Medical Officer of the District.
5. Valid relevant Category Certificate issued by the competent authority.

The appointment of the candidate shall further be subject to the following conditions:-

- i. The appointee shall furnish an undertaking in the shape of an affidavit to the effect that the appointee has no criminal record and is not facing any criminal proceedings in any Court of law.
- ii. The appointee shall give an undertaking in the shape of an affidavit to the effect that if on verification, his Qualification/ Date of Birth/Reserved Category Certificates from the concerned issuing authorities are found fake/ forged, his appointment as Junior Assistant shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- iii. That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the domicile District, he shall relinquish the

- proprietorship of unit/ enterprise before joining the Government service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. The DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/ enterprise and recovery to be made and also personally monitor its recovery.
- iv. The salary of the appointee shall not be drawn and disbursed to them unless satisfactory reports in respect of genuineness of Qualification/ Date of Birth/ Relevant Category Certificate are received from the concerned issuing authorities.
 - v. The appointee shall be on probation for a period of two years and his probation shall be regulated in terms of the provisions of the J&K Civil Service (Classification, Control and Appeal Rules), 1956.
 - vi. The appointment of the candidate shall be governed by the "New Pension Scheme" notified vide SRO 400 dated 24.12.2009.
 - vii. The inter-se-seniority of the appointee shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
 - viii. The appointment of the above candidate shall be subject to outcome of writ petition(s), if any, pending before Competent Court of law.


