WHEREAS, Rule 21(1) of J&K Civil Services (Classification, Control & Appeal), Rules, 1956, provides as under:-

*"At any time before the expiry of prescribed period of probation the appointing authority may:*

- suspend the probation of a probationer and discharge him from the service for want of vacancy; and*
- at its discretion terminate the probation of a probationer and discharge him from the service."*

NOW, THEREFORE, in terms of Rule 21(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the probation of the following Junior Assistants, is hereby terminated and are discharged from Government Service with effect from the dates as indicated against each, on their own request.
