On the recommendations of the J&K Services Selection Board and in continuation of Government Order No. 129-PW(R&B) of 2024 dated 03.05.2024, sanction is hereby accorded to the appointment of **Mr. Yasir Iqbal Drabu S/o Mohd Iqbal Drabu R/o H.No. 40, Chacknarwah, Banihal-182146, D.V. S.No. 168-KMR, Roll No. 2060005, Category-RBA, Selection Category-RBA/HCL** against the post of Junior Engineer (Mechanical) in the Public Works (R&B) Department in the Pay Level-6 (35400-112400) notionally w.e.f. 20.02.2024:-

Consequent upon the above, the appointee shall report to the office of the Chief Engineer, PW(R&B) Department, Chenab Zone within a period of twenty one (21) days from the date of issuance of this order, failing which he shall forego his right to appointment, and the same shall be deemed to have been cancelled ab-initio without any further notice.

The appointee shall be allowed to join after production of the following certificates/documents (in original) to be verified separately:-

1. Academic/Technical Qualification Certificates issued by the recognized Institute/University valid for employment.
2. Matriculation/Date of Birth Certificate issued by the recognized Education Board.
3. Domicile certificate issued by the competent authority.
4. Health Certificate from the concerned District Chief Medical Officer.
5. Valid relevant category certificate issued by the competent authority, as applicable.

The appointment of the candidate shall further be subject to the following conditions:-

- i. The appointee shall furnish an undertaking in the shape of an affidavit to the effect that the appointee have no criminal record and is not facing any criminal proceedings in any court of law.
- ii. The appointee shall furnish an undertaking in the shape of an affidavit to the effect that if on verification, his Qualification /Date of Birth/Reserved Category Certificates and other documents from the concerned issuing authority are found fake/forged, his appointment shall **be deemed to have been cancelled ab-initio** and the legal action as warranted under rules shall be initiated against him.
- iii. That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government service. The appointee shall be required to repay the entire loan liability/in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self employment unit/enterprise and recovery to be made and also personally monitor its recovery in terms of Circular No. 06-JK(GAD) of 2023 dated 06.02.2023 issued by the General Administration Department.

- iv. The salary of the appointee shall not be drawn and disbursed unless satisfactory report in respect of genuineness of his qualification/Date of Birth/Relevant Category Certificate(s) are received from the concerned issuing authority.
- v. The appointment of the candidate shall be governed by the New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- vi. The appointee shall be on probation for a period of 02 years and his probation shall be regulated in terms of the provisions of the Jammu & Kashmir Civil Services (Classification, Control & Appeal) Rules, 1956.
- vii. The inter-se-seniority of the appointee shall be determined as per the J&K Civil Services (Classification, Control & Appeal) Rules, 1956.
- viii. The appointment of the above candidate shall be subject to outcome of writ petition(s), if any, pending before any competent court of law.
