Whereas, on the recommendations of the J&K Service Selection Board, among others, Mr. Amandeep Sharma was appointed as Class-IV (MTS), vide Government Order No. 385-PW(R&B) of 2022, dated 29.10.2022; and

Whereas, vide Government Order No. 268-PW(R&B) of 2023 dated 23.06.2023, among others, the services of Mr. Amandeep Sharma, MTS were placed at the disposal of the Chief Engineer, DIQC for further posting; and

Whereas, subsequent to his appointment and joining, the Chief Engineer, DIQC vide his letter No. CE/DIQC/J/2410-11 dated 22.10.2024 informed that Mr. Amandeep Sharma, MTS through the medium of an application has tendered his resignation from the post of Class-IV (MTS) w.e.f 09.10.2024; and

Whereas, the Chief Engineer, DIQC forwarded his case to this Department for acceptance of his resignation on the grounds that the said candidate has been appointed as Customer Service Associate; and

Whereas, the matter has been examined/considered with reference to the rules governing the subject and it has been observed that the concerned official is still on probation and has not qualified for the prescribed probation period of service; and

Whereas, Rule 21(1) of J&K Civil Services (Classification, Control & Appeal), Rules, 1956, provides as under:-

"At any time before the expiry of prescribed period of probation the appointing authority may:

- a. suspend the probation of a probationer and discharge him from the service for want of vacancy; and*
- b. at its discretion terminate the probation of a probationer and discharge him from the service.*

Now, therefore, in terms of Rule 21(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the probation of Mr. Amandeep Sharma, MTS is hereby terminated and is discharged from Government Service w.e.f. 09.10.2024 on his own request.


