Subject: Resignation tendered by Sh. Satyam, Junior Engineer (Mech).

Whereas, on the recommendations of the Services Selection Board, J&K conveyed vide No. SSB/Secy/UT/03/2022/4744-49 dated: 07.06.2022, among others, Sh. Satyam, Junior Engineer (Mech) was appointed as Junior Engineer (Mechanical) vide Government Order No. 295-PW(R&B) of 2022 dated 30.08.2022; and

Whereas, vide Government order No. 295-PW(R&B) of 2022 dated 30.08.2022, among others, the services of Sh. Satyam, Junior Engineer (Mech) were placed at the disposal of the Chief Engineer, Mechanical Engineering Department, Jammu for further posting, who has joined there on 31.08.2022; and

Whereas, subsequent to his appointment/ joining, the Chief Engineer, MED, Jammu vide his letter No. CEM/J/Estt/516-18 dated: 09.05.2023 has informed that Sh. Satyam, Junior Engineer (Mech) through the medium of an application dated 04.02.2023 has tendered his resignation from the post of Junior Engineer (Mech) and has recommended the case to this department for acceptance of resignation tendered by the candidate who wants to pursue other career opportunities that better align with his personal and professional goals.

Whereas, the matter has been examined/considered with reference to the rules governing the subject and it has been observed that the concerned official is still on probation and has not qualified the prescribed probation period of service.

Whereas, Rule 21(1) of J&K Civil Services (Classification, Control & Appeal), Rules, 1956, provides as under:-

"At any time before the expiry of prescribed period of probation the appointing authority may:-

- a) **suspend the probation of a probationer and discharge him from the service for want of vacancy; and**

b) at its discretion terminate the probation of a probationer and discharge him from the service”.

Now, therefore, in exercise of the powers conferred under Rule 21(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by Sh. Satyam, Junior Engineer (Mech) is hereby accepted and is discharged from the Government service w.e.f. 03.02.2023 on his own request with the stipulation that his name shall be deemed to have been deleted from relevant seniority list.
