As recommended by the J&K Services Selection Board, sanction is hereby accorded to the appointment of Shri Robin Parihar S/o Ashok Kumar R/o Village Hidyal Nagni Kishtwar, Nagni Hidyal Nagni, Jammu, Kishtwar, Hidyal- 18224 against the post of Foreman Grade-I (Mechanical) in the Divisional Cadre Jammu under RBA Category in the pay Level-6 (35600-112400) in the Public Works (R&B) Department.

The appointee shall report in the office of the Chief Engineer, Mechanical Engineer Department, Jammu within a period of twenty one (21) days from the date of issuance of this order for further adjustment. In case the candidate fails to join within the stipulated time period, his appointment shall be deemed to have been cancelled ab-initio without any notice.

The appointee shall be allowed to join after production of the following certificates/documents (in original) to be verified separately:-

1. Educational/Technical Qualification issued by the recognized Institute/University valid for employment.
2. Matriculation/Date of Birth Certificate.
3. Domicile Certificate issued by the competent authority.
4. Health Certificate from the concerned District Chief Medical Officer.
5. Certificate from the District Industries Centre (DIC) and District Employment and Counselling Centre to the effect that no loan under any self employment scheme has been availed by the candidate.

6. Valid relevant category certificate issued by the competent authority.

The appointment of the above candidate shall further be subject to the following conditions:-

- i) The appointee shall furnish an undertaking in the shape of an affidavit to the effect that the appointee have no criminal record and is not facing any criminal proceedings in any Court of Law.
- ii) The salary of the appointee shall not be drawn and disbursed to them unless satisfactory report in respect of genuineness of their qualification/degree certificate/ Date of Birth/relevant category certificate is received from the concerned issuing authority.
- iii) The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- iv) The inter-se-seniority of the appointee shall be determined in accordance with the merit secured by the appointee in the selection list prepared by the Services Selection Board.
- v) The selection list is available on the website of the J&K Services Selection Board (www.jkssb.nic.in) and shall be cross verified from it.
- vi) The appointment of the above candidate shall be subject to outcome of Writ Petition(s), if any, pending before any competent Court of Law.


