On the recommendations of the J&K Service Selection Board and in continuation of Government Order No. 318-PW(R&B) of 2024 dated 18.11.2024, sanction is hereby accorded to the temporary appointment of Mr. Krishan Lal S/o Inder Kumar, R/o H. No. 29, Ward No. 04, Nadalan, Rajpura, Samba-184145, as Junior Engineer (Civil) in the Public Works (R&B) Department in the Pay Level-6 (35400-112400) under ALC/IB Category.

Consequent upon the appointment, the appointee shall report to the Chief Engineer, PW (R&B) Department, Zone Jammu within a period of twenty one (21) days from the date of issuance of this order. In case the candidate fails to join within the stipulated period, his appointment shall be deemed to have been cancelled ab-initio.

The appointee shall be allowed to join after production of the following certificates/ documents (in original) to be verified separately:-

- Academic/ Technical Qualification Certificates Issued by recognized Institute/ University.
- 2. Matriculation/ Date of Birth Certificate issued by a recognized Educational Board.

Domicile Certificate issued by the competent authority.

Operating of wait list thereof.

- 4. Health Certificate from the concerned Chief Medical Officer of the District.
- Valid relevant Category Certificate issued by the competent authority, if any applicable.

The appointment of the candidate shall further be subject to the following conditions:-

- i. The appointee shall furnish an undertaking in the shape of an affidavit to the effect that if on verification, his Qualification/ Date of Birth/ Reserved Category Certificates from the concerned issuing authorities are found fake/ forged, his appointment shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
 - That if the candidate has taken loan for self employment from DIC/ Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he shall relinquish the proprietorship of unit/ enterprise before joining the Government service. He shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his salary. The DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes,

- if any, in such a self-employment unit/ enterprise and recovery to be made and also personally monitor its recovery.
- iii. The salary of the appointee shall not be drawn and disbursed unless satisfactory reports in respect of the genuineness of Qualification/ Date of Birth/ Relevant Category Certificate are received from the concerned issuing authority. IV.
- The appointee shall be on probation for a period of two years and his probation shall be regulated in terms of the provisions of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956. ٧.
- The appointment of the candidate shall be governed by the "New Pension Scheme" as notified vide SRO 400 dated 24.12.2009.
- vi. The inter-se-seniority of the appointee shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- vii. The appointment of the candidate shall be subject to outcome of writ petition(s), if any, pending before any Competent Court of law.
