AND WHEREAS, Rule 21(1) of J&K Civil Services (Classification, Control & Appeal) Rules, 1956, governs regulation of probation in the Government service and provides as under:-

"At any time before the expiry of prescribed period of probation the appointing authority may:

- suspend the probation of a probationer and discharge him from the service for want of vacancy; and
- at its discretion terminate the probation of a probationer and discharge him from the service".
