Administrative Approval is hereby accorded for "Construction of Steel Girder through type intermediate lane motorable bridge over river Chenab at Shiva Dal, Prem Nagar Doda (including right approach)" under Road Sector of Capex Budget for an amount of Rs 1363.73 lakh as per the details/ cost abstract enclosed as Annexure "A" to this order.

The Administrative Approval however is subject to the fulfillment of following conditions:

1. That the project is strictly devised and designed as per latest relevant I.S. Codes and specifications of PWD/CPWD/MoRTH and the same is authenticated and proof checked by the competent authority.
2. That the standard specifications are followed as per CPWD, NBC and IS standards
3. That the work is executed after observing all Codal/ procedural formalities.
4. That the detailed estimate of work is technically sanctioned by the competent authority.
5. It must be ensured that there shall be no multi-source funding or overlapping of schemes under different programmes.
6. That no diversion of funds from one scheme to another scheme shall be made.
7. That the funds shall be released by the controlling officer to the extent of actual work done as per approved provisions in the estimate after fulfilling all codal/ procedural formalities.
8. That the work done amount for the work done part of the DPR for the Project is based on actual details at site and on allotted/ approved rates, approved by the competent authorities in accordance with set codal procedures.
9. That the contracts for executed/allotted part of the project have been awarded on competitive and reasonable rates in accordance with set codal provisions and by following set guidelines/procedures governing the field.

10. That the lump-sum provisions, either in terms of percentage or fixed as made for certain components of the DPR are provisional and shall be subject to detailed estimates based on actual details/requirements and relevant rates, to be framed and approved by the competent authority well before invitation of tenders in accordance with set codal procedures.
11. That the rates for the items not covered in JK SSR or any other relevant schedule shall conform to Analysis of rates based on authentic Data Book, to be computed and approved by the competent authority well before invitation of tenders in accordance with set codal procedures.
12. That the working BOQs, based on approved design details/requirements, are framed as per J&K PWD Schedule of Rates for e-tendering purpose of the project.
13. That e-tendering mode is followed for fixation of the award of contract for execution of the project. Fragmentation of the project while tendering is not allowed.
