Whereas, on the recommendations of the Services Selection Board, J&K conveyed vide No. SSB/Secy/Sel/Class- IV/2021/6273-78 dated 18.10.2022 and the General Administration Department's O.M. No. GAD/MTGRDIV/267/2022-09-GAD dated 27.10.2022, among others, Sh. Sameer Amin was appointed as Class IV (MTS) vide Government order No. 387-PW(R&B) of 2022 dated 29.10.2022; and

Whereas, vide Government order No. 387-PW(R&B) of 2022 dated 29.10.2022, among others, the services of Shri Sameer Amin (MTS), Road worker were placed at the disposal of the Chief Engineer, PW(R&B) Kashmir for further posting, who has joined there on 31.10.2022; and

Whereas, subsequent to his appointment/joining, the Chief Engineer, PW(R&B) Kashmir vide his letter No. CE/RBK/ADM/9083-85 dated: 12.07.2023 has informed that Shri Sameer Amin (MTS), Road worker through the medium of an application dated 13-06-2023 has tendered his resignation from the post of Class-IV (MTS); and

Whereas, the Chief Engineer, PW(R&B) Kashmir forwarded his request to the Public Works (R&B) Department for acceptance of his resignation as the said candidate has been selected as Junior Assistant in General Administration Department, Civil Secretariat, J&K vide Govt. Order No. 678-JK (GAD) of 2023 dated: 13-06-2023 and;

Whereas, the matter has been examined/considered with reference to the rules governing the subject and it has been observed that the concerned official is still on probation and has not qualified the prescribed probation period of service.

Whereas, Rule 21(1) of J&K Civil Services (Classification, Control & Appeal), Rules, 1956, provides as under:-

"At any time before the expiry of prescribed period of probation the appointing authority may:-

- a) **suspend the probation of a probationer and discharge him from the service for want of vacancy; and**
- b) **at its discretion terminate the probation of a probationer and discharge him from the service".**

Now, therefore, in exercise of the powers conferred under Rule 21(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by Shri Sameer Amin Class-IV (MTS) is hereby accepted and is discharged from the Government service with effect from the date, the applicant submitted resignation i.e. 13.06.2023 on his own request.
