Subject:- Acceptance of three years diploma in civil Engineering (Civil) acquired by Mr. Sudhir Singh Jamwal, Draftsman and inclusion of his name in the seniority list of Diploma holders Draftsman (Civil)

Whereas, the Chief Engineer, PW(R&B), Jammu vide his letter dated 11.01.2023 has forwarded the case of Mr.Sudhir Singh Jamwal, Draftsman (Civil) for acceptance of his three years diploma in civil Engineering and inclusion of his name in the seniority list of Diploma holders Draftsman (Civil).

Whereas, the case was examined in the department a-n-d vide this department's letter dated 06.02.2023 , visible/ readable copies of some deficient documents were sought from the Chief Engineer R&B Jammu who vide his letter dated 20.02.2023 has provided the same. As per documents submitted by the concerned Chief Engineer, the particulars of the candidate are as under:-

Whereas, the case was examined in the department and Diploma/ marks certificates of the candidate were forwarded to the Secretary State Board of Technical Education J&K, Jammu vide letter dated 13.03.2023 for verification/ authentication of genuineness of the Diploma acquired by the said candidate. In response, the J&K Board of Technical Education, Srinagar vide their communication No. BOTE/ Exam/ Verf/23/ 1189 dated 28.04.2023 has verified/ authenticated the Diploma certificate acquired by the candidate.

Whereas, the above incumbent has also produced undertaking in the shape of Affidavit duly attested by the Chief Judicial Magistrate affirming therein that he has passed diploma in civil engineering and the same has not tempered/

fabricated and he shall be personally responsible for the same, if at any time is found fraudulent.

Whereas, a notice was issued on 23.05.2023 for inviting therein objections from the members of the cadre who are likely to be affected due to decision of the department. In response, the Chief Engineer, PW(R&B) Jammu vide his letter dated 23.06.2023 has intimated that his office has not received any objection/s from any person regarding proposed action of the department..

Whereas, the case has been re-examined in the department and it has been decided to accept the diploma certificates acquired by the above named official, treat him as Diploma holder Draftsman (civil) and include his name at appropriate place in the relevant seniority list of Diploma holders Draftsman (civil) as and when the same is updated/notified by the department.

Now therefore, Mr. Sudhir Singh Jamwal, Draftsman Civil shall henceforth be treated as Draftsman (Civil) Diploma holder and subsequently his name shall be included at appropriate place in the relevant seniority list of Diploma Holders Draftsman (Civil) as and when the same is updated/ notified afresh by the Administrative Department.
