1. The concerned Head of the Department shall sanction Earned Leave in favour of the above-mentioned Engineer for specified period of visit.
2. The concerned Engineer shall strictly adhere to the specified dates and the leave shall not be extended beyond the approved period.
3. The concerned Engineer shall submit an Affidavit affirming therein that:
a) he will not extend his leave beyond the specified period under any circumstances.
b) He will not engage in any form of employment, whether full time or part time, including private-practice, consultancy, or any other professional activity during his visit abroad.
4. The concerned Engineer shall not engage in any activity that violates the Employees Conduct Rules during his foreign visit.
5. The Drawing and Disbursing Officer shall ensure that the details of the foreign visit and the sanctioned leave period are duly recorded in the service book of the Engineer.
