WHEREAS, on the recommendations of the Services Selection Board, J&K, among others, Mr. Suheel Ahmad Sheikh was appointed as Class IV (MTS), vide Government Order No. 388-PW(R&B) of 2022, dated 29.10.2022;

AND WHEREAS, vide Government Order No. 388-PW(R&B) of 2022, dated 29.10.2022, among others, the services of Mr. Suheel Ahmad Sheikh (MTS), Road worker were placed at the disposal of the Chief Engineer, PW(R&B) Department, South Kashmir for further posting;

AND WHEREAS, subsequent to his appointment and joining, the Chief Engineer, South Kashmir vide his letter No. CE/R&B/SK/ADM/3959-61 dated 30.07.2024 informed that Mr. Suheel Ahmad Sheikh (MTS), Road worker, through the medium of an application has tendered resignation from the post of Class-IV (MTS) w.e.f 25.06.2024;

AND WHEREAS, the Chief Engineer, South Kashmir forwarded his case to this Department for acceptance of his resignation by the competent authority on the grounds that the said candidate has been appointed as Panchayat Secretary in Rural Development Department;

AND WHEREAS, the matter has been examined and considered with reference to the rules governing the subject and it has been observed that the concerned official is still on probation and has not qualified the prescribed probation period of service;

WHEREAS, Rule 21(1) of J&K Civil Services (Classification, Control & Appeal), Rules, 1956, provides as under:-

> "At any time before the expiry of prescribed period of probation the appointing authority may:

- a. suspend the probation of a probationer and discharge him from the service for want of vacancy; and
- b. at its discretion terminate the probation of a probationer and discharge him from the service."

NOW THEREFORE, in terms of Rule 21(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the probation of Mr. Suheel Ahmad Sheikh, MTS (Road Worker) is hereby terminated and he is discharged from Government Service w.e.f. 25.06.2024, on his own request.
