Subject: Acceptance of Degree of Er.Danish Mohd Tantray, Junior Engineer (Civil) Diploma holder and inclusion of his name in the seniority list of Junior Engineers (Civil) Degree Holders.

Government Order No. 362 –PW(R&B) of 2021

Whereas, as per provisions of J&K Engineering (Subordinate) Service Recruitment Rules, 1997, a Junior Engineer, Diploma holder after acquiring Degree in relevant branch of Engineering is to be treated as Degree holder for the purpose of seniority from the date of completion/ passing of Degree; and

Whereas, the Chief Engineer, PMGSY, (JKRRDA) Jammu vide his letter dated 16.08.2021 has forwarded the case of Er.Danish Mohd Tantray, Junior Engineer, PMGSY Division, Rajouri for acceptance of his Degree and inclusion of his name in the seniority list of Degree holders Junior Engineers (Civil) whose particulars are given as under:-

Whereas, the provisional Degree/ marks certificates of the Er.Danish Mohd Tantray were forwarded to the Controller of Examination, Baba Ghulam Shah Badshah University, Rajouri vide this department's letter dated 24.08.2021 for verification of genuineness of the Degree acquired by the Junior Engineer. In response, the Controller of Examinations, Baba Ghulam Shah Badshah University, Rajouri vide his communication No.BGSBU/ CoE/ 2021/ 3564 dated 03.09.2021 has verified/ authenticated

the Degree/ marks certificates of the aforesaid Engineer with the remarks that the candidate has pursued B E Civil from the University under regular mode during 2018-21 and passed out on 02.07.2021 .

Whereas, the above named Engineer has also produced undertaking in shape of Affidavit dully attested by the 1st Class Judicial Magistrate, affirming therein that in case any information about his Degree is found fraudulent/ bogus at any time during service, the same shall be deemed to be cancelled ab-initio and action as warranted under rules shall be initiated against him in terms of J&K Civil Services (Classification, Control & Appeal) Rules, 1956.

Whereas, the case was examined in the department and it has been observed that there is a case to accept his Degree from the date of passing his Degree and include his name at appropriate place in the seniority list of Degree Holders Junior Engineers (Civil) as and when the same is notified afresh and also exclusion of his name from the seniority list of Junior Engineer (Civil-Diploma holders).

Whereas, the case was further examined in the department and notice was issued on 28.09.2021 for inviting therein objection/s from the members of the cadre who are likely to be affected due to decision of the department. In response, the Chief Engineer, PMGSY (JKRRDA), Jammu vide his letter dated 10.11.2021 has intimated that none of the members of the cadre or otherwise, have filed objections in his office and also has requested that his name may be placed at the appropriate place in the seniority of Degree holders Junior Engineers under rules.

Whereas, the Finance Department has issued circular instructions under endorsement No.A/HACM (2012)-PMO-49 dated 01.02.2019 clarifying therein that the advance increments to degree holders on their appointment as Junior Engineers are available on initial appointment and not at the time of acquiring degree after entry into Government Service as Diploma holder.

Now, therefore, Er.Danish Mohd Tantray, Junior Engineer (Civil) Diploma holder shall henceforth be treated as Junior Engineer (Civil) Degree holder and his name shall be included at appropriate place in the seniority list of Junior Engineers (Civil) Degree Holders as and when the same is notified afresh, besides, his name shall be deemed to be excluded from the



seniority list of Junior Engineers (Civil) Diploma holders. However, the pay of the Engineer shall be regulated as per circular instructions issue by the Finance Department under endorsement No.A/HACM (2012)-PMO-49 dated 01.02.2019.


