Subject: - Application for the grant of permission/NOC for undergoing Phd Programme at Indian Institute of Technology , Bombay in favour of Mr. Nadeem Akbar Najar, Junior Engineer, (Mechanical).

Whereas, the Chief Engineer Mechanical Engineering Department, Kashmir vide communication No CEMK/Adm/3019 dated 06-10-2021 mooted a proposal for grant of permission/ NOC in favour of Mr. Nadeem Akbar Najar, Junior Engineer (Mechanical) to undergo PhD programme at Indian Institute of Technology, Bombay; and

Whereas the case was examined and vide departments letter dated 18-10-2021, the Chief Engineer MED, Kashmir was requested to intimate in the first instance, as whether Mr Nadeem Akbar Junior Engineer has joined the Phd programme, if not, furnish fresh date of commencement of the programme from the IIT Bombay in respect of the official; and

Whereas, in turn, the Chief Engineer Mechanical Engineering Department , Kashmir vide communication No MED/K/ASd//3359 dated 01-11-2021 intimated that Mr Nadeem Akbar Najar Junior Engineer (Mechanical) got selected in PhD Course at Indian Institute of Technology, Bombay in May, 2019 and was supposed to join the Institute in the month of July, 2019 but the applicant could not join the course, due to lack of requisite length of service; and

Whereas, it has been further observed that the admission in favour of Mr. Nadeem Akbar, Najar, JE was cancelled by IIT Bombay and the applicant requested the IIT Bombay to revoke the cancellation of admission, which was accepted by the Institute and communicated to the applicant vide their office communication No Acad/PhD/194467003/CPS/2020 dated 21-01-2020; and

Whereas, due to pandemic, the country wide lock-down was imposed by the Government in April, 2020 and all the educational institutes including IIT Bombay, decided to conduct their classes in online mode for two semesters; and

Whereas, Mr Nadeem Akbar Najar, Jr Engineer was asked by the IIT Bombay to complete the course work requirements for the PhD programme and completed in November, 2020 and the Engineer was

relieved of the requirements for undergoing online courses for one year at IIT Bombay in person; and

Whereas, Mr Nadeem Akbar Najar, Jr Engineer was required to join the PhD programme with prior permission, however, in view of the online course work attended by the applicant, which has not hampered his official duties, it has been felt that due consideration shall be given in the case.

Now, therefore, it is hereby ordered that:

- I. Post facto sanction is accorded to the grant of higher study permission in favour of Mr. Nadeem Akbar Najar, Junior Engineer (Mechanical) for completing Phd Course w.e.f. 01.01.2020 for a period of one year through online mode from Indian Institute of Technology Bombay in terms of Rule 67 and Rule 73 of J&K CSR (Leave) Rules, 1979 re-casted vide SRO-274 dated 30.5.2013 Clause (2) notified by the Finance Department.
- II. the Chief Engineer, MED, ;Kashmir shall take a note of degree acquired by the Engineer without obtaining the prior permission and to warn the official for violation of service/conduct rules henceforth.


