The appointee(s) shall report to the office of the Chief Engineer, Mechanical Engineering Department, Kashmir within a period of twenty one (21) days from the date of issuance of order. In case any candidate fails to join within the stipulated time period, his/her appointment shall be deemed to have been cancelled ab-initio without any notice.

The appointee(s) shall be allowed to join after production of the following certificates/documents (in original) to be verified separately:-

1. Educational/Technical Qualification Degree (Degree certificates) issued by the recognized Institute/University valid for employment
2. Matriculation/Date of Birth Certificate from recognized Education Board.
3. Domicile certificate issued by the competent authority.
4. Health Certificate from the concerned District Chief Medical Officer.

5. Certificate from the District Industries Centre (DIC) and District Employment and Counseling Centre to the effect that no loan under any self employment scheme has been availed by the candidate.
6. Valid relevant category certificate issued by the competent authority, if any applicable.

The appointment of the above candidates shall further be subject to the following conditions:-

- I. The appointee(s) shall furnish an undertaking in the shape of Affidavit to the effect that the appointee have no criminal record and is not facing any criminal proceedings in any court of law.
- II. The salary of the appointee(s) shall not be drawn and disbursed unless a satisfactory report in respect of genuineness of their qualification/degree certificate/ Date of birth/ relevant category certificate is received from the concerned issuing authority.
- III. The appointment of the candidate(s) shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- IV. The inter-se-seniority of the appointee(s) shall be determined in accordance with the merit secured by the appointee in the selection list prepared by the Services Selection Board.
- V. The selection list is available on the website of the J&K Services Selection Board (www.jkssb.nic.in) and shall be cross verified from it.
- VI. The appointment of the candidate(s) shall be subject to outcome of Writ Petition(s), if any, pending before competent court of law.


