Whereas, the J&K Services Selection Board vide communication No. JKSSB-PLAN/25/2022-03 dated 03.03.2023, forwarded the selection list of 162 candidates for the post of Junior Assistant in the Public Works (R&B) Department; and

Whereas, subsequently vide Notice issued under endorsement No. PWD-NGAZ0CIV/60/2023-05 (7145499) dated 20.03.2023, among other candidates, Shri Deepak Jarngal S/o Sh. Shashi Kumar R/o Railway Road Ghurha Mundian, Hira Nagar, Kathua selectee was advised to submit his Email Address and Mobile Number for registration under Employee Verification System (EVS); and

Whereas, after receipt of the credentials of the said candidate, among others, the same was forwarded to Criminal Investigation Department online through EVS Portal for obtaining his Character and Antecedents report; and

Whereas, on the basis of report furnished by the Criminal Investigation Department, J&K, vide Form No. 59678 , among others, Shri Deepak Jarngal S/o Sh. Shashi Kumar R/o Railway Road Ghurha Mundian, Hira Nagar, Kathua was appointed as Junior Assistant vide Government Order No. 208-PW(R&B) of 2023 dated 25.05.2023 issued under endorsement No. PWD- NGAZ0CIV/60/2023-05 dated 25.05.2023 and his services were placed at the disposal of Chief Engineer PW(R&B) Department Kashmir for further adjustment;

Whereas, the candidate was directed to report to the office of the Chief Engineer, PW(R&B)Department Kashmir within a period of twenty one (21) days from the date of issuance of appointment order;

Whereas, among other conditions, it was also stipulated that if the candidate fails to join within a period of 21 days , his appointment shall be deemed to have been cancelled ab-initio without any notice; and

Whereas, the Chief Engineer PW(R&B) Department Kashmir vide communication No. CE/RBK/Adm/11818 dated: 14.08.2023 has intimated that Shri Deepak Jarngal S/o Sh. Shashi Kumar R/o Railway Road Ghurha Mundian, Hira Nagar, Kathua, appointed as Junior Assistant has not joined in his office within the stipulated time.

Now therefore, in view of the aforementioned report furnished by the Chief Engineer PW(R&B) Kashmir in the matter, it is hereby ordered that the appointment of Shri Deepak Jarngal S/o Sh. Shashi Kumar R/o Railway Road Ghurha Mundian, Hira Nagar, Kathua as Junior Assistant in the Public Works (R&B) Department pursuant to Government Order No.208-PW(R&B) of 2023 dated 25.05.2023 is hereby cancelled ab-initio.


