On the recommendation of the J&K Services Selection Board and in continuation of Government Order No. 49-PW(R&B) of 2023 dated: 31/01/2023, sanction is hereby accorded to the temporary appointment of Sh. Younis Nisar S/o Sh. Nisar Ahmed R/o Mehdhar, Poonch (Sl.S.No.1, D.V.S.No. 17-JMU, Roll No. 10366, Category-EWS) against the post of Draftsman (Mechanical), in the Pay Level-4 (25500-81100) in the Public Works (R&B) Department, in whose favor the verification report has been received from the Criminal Investigation Department.

The appointee shall report to the office of the Chief Engineer, Mechanical Engineering Department, Jammu within a period of twenty one (21) days from the date of issuance of this order. In case the appointee fails to join within the stipulated time period, his appointment shall be deemed to have been cancelled ab-initio without any notice.

The appointee shall be allowed to join after production of the following certificates/documents (in original) to be verified separately:-

1. Educational/Technical Qualification Degree (Degree certificates) issued by the recognized Institute/University valid for employment.
2. Matriculation/Date of Birth Certificate from recognized Education Board.
3. Domicile certificate issued by the competent authority.
4. Health Certificate from the concerned District Chief Medical Officer.
5. Valid relevant category certificate issued by the competent authority, if any applicable.
6. That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government service. He/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self employment unit/enterprise and recovery to be made and also

personally monitor its recovery in terms of Circular No. 06-JK(GAD) of 2023 dated 06.02.2023 issued by the General Administration Department.

The appointment of the above candidate shall further be subject to the following conditions:-

1. The appointee shall furnish an undertaking in the shape of Affidavit to the effect that the appointee have no criminal record and is not facing any criminal proceedings in any court of law.
2. The salary of the appointee shall not be drawn and disbursed unless a satisfactory report in respect of genuineness of his qualification/degree certificate/ Date of birth/ relevant category certificate is received from the concerned issuing authority.
3. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
4. The appointee is on probation for the period of 02 years.
5. The inter-se-seniority of the appointee shall be determined in accordance with the merit secured by the appointee in the selection list prepared by the Services Selection Board.
6. The selection list is available on the website of the J&K Services Selection Board ([www.jkssb.nic.in](http://www.jkssb.nic.in)) and shall be cross verified from it.
7. The appointment of the candidate shall be subject to outcome of Writ Petition(s), if any, pending before competent court of law.
