Subject: Appointment of Class-IV posts in the Public Works Department selected under provisions of the Jammu & Kashmir Appointment to Class-IV (Special Recruitment) Rules, 2020 pursuant to Advertisement Notification No. 01 of 2020 dated 26.6.2020. Cancellation thereof.

Government Order No. 380 - PW(R&B) of 2021,
Dated: 23 -12-2021.

Whereas, the General Administration Department constituted Accelerated Recruitment Committee (ARC) vide Government order No. 559-JK(GAD) of 2020 dated 14.5.2020 for coordinating the referral of all vacancies existing for direct recruitment at Class-IV level; and

Whereas, the Public Works (R&B) Department furnished the indent for filling of posts available with the Department to the aforesaid constituted Committee, which had been identified under UT/Divisional Cadres; and

Whereas, the Accelerated Recruitment Committee (ARC), among other cadre vacancies, forwarded 1450 vacancies of Class-IV pertaining to Public Works (R&B) Department to the General Administration Department for their further referral to Jammu and Kashmir Services Selection Board under Rule 4 of the Jammu and Kashmir Appointment to Class-IV (Special Recruitment) Rules, 2020; and

Whereas, the General Administration Department vide indent No. GAD/Mtg/RB-IV/50/2020 dated 22.6.2020, referred 8575 Class-IV posts of various departments including 1450 posts pertaining to Public Works Department to the J&K Services Selection Board for making selection of suitable candidates under the provisions of Jammu and Kashmir Appointment to Class-IV (Special Recruitment) Rules, 2020 notified vide S.O. 184 of 2020 dated 04.6.2020; and

Whereas, the Services Selection Board vide letter No. SSB/Secy/Sel/Class-IV/2021/7103-11 dated 18.10.2021, recommended the selection list of 5115 candidates and 60 posts have been kept withheld against these Class-IV indented posts of various cadres to the General Administration Department for further necessary action; and

Whereas, the General Administration Department vide O.M No.GAD/MTGORBIV/63/2021-09-GAD dated 19.10.2021 forwarded the selection list recommended by the Services Selection Board to this department for issuing

appointment orders in respect of the 622 candidates in the Public Works (R&B) Department as per the standard terms and conditions already issued from time to time by the Government; and

Whereas, on the recommendation of the J&K Services Selection Board duly endorsed by the General Administration Department, the department issued formal appointment orders in favour of the candidates, whose verification reports got received from the Criminal Investigation Department duly endorsed by the concerned Deputy Commissioners; and

Whereas, the appointee(s) had been directed to report to the office of the Chief Engineer, PW(R&B) Department Jammu/Kashmir within a period of 21 days from the date of issuance of order and such candidates who fail to join within the stipulated time, shall forego their right to appointment, and the same shall be deemed to have been cancelled ab-initio without any further notice; and

Whereas, the Chief Engineer, PW(R&B) Department Kashmir vide his office communication No. CE/RBK/ADM/29741 dated 25.11.2021 reported that the following candidates have failed to join within the stipulated time period of 21 days, prescribed in their appointment orders:-


