The appointee(s) shall be allowed to join after production of the following certificates/documents (in original) to be verified separately:-

1. Educational/Technical Qualification Degree issued by the recognized Institute/University valid for employment
2. Matriculation/Date of Birth Certificate issued by the recognized Education Board.
3. Domicile certificate issued by the competent authority.
4. Health Certificate from the concerned District Chief Medical Officer.
5. Valid relevant category certificate issued by the competent authority, if any applicable.
6. That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counseling Centre of the domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government service. He/she shall be required to repay the entire loan liability/in suitable EMIs to be worked out by the DDO concerned from his/her salary. - vii. The appointment of the above candidates shall be subject to outcome of writ petition(s), if any, pending before any competent court of law.


