3. The Engineer shall submit an affidavit to the effect that he shall not take part in any employment/assignment either full-time or part-time basis including private profession, practice and consultancy etc., in the foreign country during his visit.
4. The Engineer shall not engage in any such activities which are unbecoming of a Government servant during the visit
