Whereas, on the basis of indent/requisition from the Public Works (R&B) Department vide No. PW(R&B)/NG/124/2019 dated 30.09.2020 followed by No. PW(R&B)/NG/124/2019 dated 17.12.2020, the J&K Services Selection Board vide letter No. JKSSB/23/2023-03(E-7164134) dated 21.06.2023 issued a selection list of 08 posts of Junior Stenographers advertised vide Notification No. 05 of 2020 dated 24.12.2020 in the Public Works (R&B) Department with the following breakup; and

Whereas, on the basis of final verification reports as received from the Criminal Investigation Department vide Form No.s 67635 dated 22.07.2023, 67659 dated 18.08.2023, 67661 dated 08.08.2023, 67658 dated 10.08.2023, 67663 dated 02.08.2023, 67657 dated 25.07.2023 and 67662 dated 26.07.2023, the department issued appointment orders in their favour vide different

Government Orders viz Government Order No. 306- PW(R&B)of 2023 dated 27.07.2023, Government Order No.318-PW(R&B)of2023 dated 02.08.2023, Government Order No. 329-PW(R&B) of 2023 dated 14.08.2023, Government Order No. 347-PW(R&B) of 2023 dated 22.08.2023 and Government Order No. 363-PW(R&B) of 2023 dated 31.08.2023; and

Whereas, the services of these 07 Jr. Stenographers were placed at the disposal of Chief Engineer, R&B Jammu/Kashmir as well as the Chief Engineer, PMGSY(JKRRDA) Kashmir for further adjustment; and

Whereas, vide Government Order No. 22-JK(GAD) of 2023 dated 06.01.2023, the Public Works (R&B) Department got reorganized/restructured by merging/subsuming the Engineering wings of 10 other departments, wherein the post of Jr. Stenographers were not reflected and thus their salaries are withheld, as these posts are reduced in the Reorganization process of the department; and

Whereas, the candidates selected against the post of Jr. Stenographer have been representing to this department for release of their salaries; and

Now, therefore, in view of the above and for the purpose of drawl of salaries, sanction is hereby accorded to the withdrawal of 07 No. of posts of Head Assistant from R&B Divisions (04 from Kashmir and 03 from Jammu) and placed at the disposal of Chief Engineer Jammu Zone/Central Kashmir for the purpose of drawl of salary only as per following details:
