Sanction is hereby accorded to the temporary appointment of Mr. Sajad Ahmad Chachi (Gojar) S/o Late Shamas Din Gojar R/o Katiyanwali Baramulla as Class-IV (MTS) Road Worker in the pay level of SL1 (14800-47100) in the Public Works (R&B) Department, North Kashmir in relaxation of the Qualification bar in terms of Rule-7 of SRO-43 of 1994 conveyed by the General Administration Department vide U.O/O.M.GAD-SRO/96/ 2023 (7317734) dated 06.01.2024 and verification report of character and antecedents received from the Criminal Investigation Department vide Verification No.92952 dated 23.01.2024 and form No. 92876 dated 23.01.2024.

Consequent upon appointment, the appointee shall report to the office of the Chief Engineer, Public Works (R&B) Department, North Kashmir within a period of twenty one (21) days from the date of issuance of this order. In case the candidate fails to join within the stipulated period, his appointment shall be deemed to have been cancelled ab-initio without any notice.

The appointee shall be allowed to join on production of the following certificates/documents (in original) to be verified subsequently:

1. Educational/Technical Qualification issued by the recognized Institute/University valid for employment.
2. Matriculation/Date of Birth Certificate issued by the recognized Education Board.
3. Dependent Certificate issued by the Assistant Commissioner, Revenue
4. Domicile certificate issued by the competent authority.
5. Health Certificate from the concerned District Chief Medical Officer.
6. Valid relevant category certificate issued by the competent authority, if any applicable.
7. That if the candidate has taken loan for self employment from DIC/Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the domicile District, he shall relinquish the

proprietorship of unit/enterprise and also stakes, if any, in such self employment unit/enterprise before joining the Government service. He shall be required to repay the entire loan liability/in suitable EMIs to be worked out by the DDO concerned from his salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self employment unit/enterprise and recovery to be made and also personally monitor its recovery in terms of Circular No. 06-JK(GAD) of 2023 dated 06.02.2023 issued by the General Administration Department.

Besides, the appointment of the above candidate shall further be subject to the following conditions:-

- i. The appointee shall furnish an undertaking in the shape of an affidavit to the effect that the appointee have no criminal record and is not facing any criminal proceedings in any court of law.
- ii. If, on verification of the qualification certificates/DOB and other documents from the concerned issuing authority are proved fake/forged, the claim of his appointment shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against him.
- iii. The salary of the appointee shall not be drawn and disbursed to him unless satisfactory report in respect of genuineness of his qualification/degree certificate/Date of birth/relevant category certificate is received from the concerned issuing authority.
- iv. The appointment of the candidate shall be governed by the "New Pension Scheme" as per SRO-400 of 2009 dated 24.12.2009.
- v. The appointee shall be on probation for a period of 02 years.
