Subject:- Acceptance of the resignation of Shri Atul Bhagat and Vikram Singh , Road Worker-discharge thereof.

WHEREAS, on the recommendations of the Services Selection Board, J&K conveyed vide No. SSB/Secy/Sel/Class- IV/2021/6273-78 dated 18.10.2022 and General Administration Department's O.M. No. GAD/MTGRDIV/267/2022-09-GAD dated 27.10.2022, Shri Atul Bhagat and Vikram Singh among others, got appointed to the post of Class IV (Road Worker) vide Government order No. 386-PW(R&B) of 2022 dated 29.10.2022 ; and

Whereas, vide Government order No. 386-PW(R&B) of 2022 dated 29.10.2022, among others, the services of Atul Bhagat and Sh. Vikram Singh , Road worker were placed at the disposal of the Chief Engineer, PW(R&B) Department Kashmir for further posting;

Whereas, while being posted in the Chief Engineer, PW(R&B) Department, Kashmir, Atul Bhagat and Vikram Singh, joined on 14.11.2022 and 11-11-2022 respectively and accordingly posted in Divisions vide office order No. K-159(ADM) of 2022 dated 16.11.2022 and K-156 (ADM) of 2022 dated 16.11.2022 by the Chief Engineer; and

Whereas, subsequent to their appointment, the Chief Engineer, PW(R&B) Department Kashmir vide letter No. CE/RBK/ADM/25856-60 dated 02.12.2022 reported that the appointees through the medium of an application have tendered resignation from the post of Road Workers with the reasons that they have been selected/appointed in another job at Jammu; and

Whereas, the Chief Engineer, PW(R&B) Department, Kashmir forwarded their request to the Public Works (R&B) Department for acceptance of their resignation;and

Whereas, the matter has been considered with reference to the rules governing the subject and it has been found that the officials are still on probation and have not qualified the prescribed service period.

Now, therefore, in exercise of the powers conferred under Rule 22(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by Shri Atul Bhagat and Sh. Vikram Singh, Road Workers is hereby accepted and are discharged from the Government service w.e.f. 21.11.2022 and 22.11.2022 respectively on their own request.


