The appointees shall be allowed to join after production of the following certificates/ documents (In original) to be verified separately:-

- Academic/ Technical Qualification Certificates issued by a recognized Institute/ University.
- Matriculation/ Date of Birth Certificate issued by a recognized Educational Board.
- Domicile Certificate issued by the competent authority.
- Health Certificate from the concerned Chief Medical Officer of the District.
- Valid relevant Category Certificate issued by the competent authority, if any applicable.

The appointment of the candidates shall further be subject to the following conditions:-

- i. The appointees shall furnish an undertaking in the shape of an affidavit to the effect that if on verification, their Qualification/ Date of Birth/ Reserved Category Certificates from the concerned issuing authorities are found fake/ forged, their appointment shall be deemed to have been cancelled ab-initio and the legal action as warranted under rules shall be initiated against them.
- ii. That if the candidate(s) has taken loan for self employment from DIC/ Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment & Counselling Centre of the domicile District, they shall relinquish the proprietorship of unit/ enterprise before joining the Government service. They shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from their salary. The DDO concerned shall obtain an affidavit from the concerned appointee(s) regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/ enterprise and recovery to be made and also personally monitor its recovery.
- iii. The salary of the appointees shall not be drawn and disbursed unless satisfactory reports in respect of the genuineness of Qualification/ Date of Birth/ Relevant Category/ Domicile Certificate are received from the concerned issuing authority.
- iv. The appointees shall be on probation for a period of two years and their probation shall be regulated in terms of the provisions of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956.
- v. The appointment of the candidates shall be governed by the "New Pension Scheme" as notified vide SRO 400 dated 24.12.2009.
- vi. The inter-se-seniority of the appointees shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- vii. The appointment of the candidates shall be subject to outcome of writ petition(s), if any, pending before any Competent Court of law.
