**Subject:-** Accord of Post Facto Administrative Approval to the "Construction of road from Rajouri to Baba Ghulam Shah Badshah (BGSB) University" Length 8.00 Kms (7.00 Kms Flexible + 1.00 Kms Rigid Pavement) at an estimated cost of Rs 31.52 Crore under Languishing Projects Programme (LUP1943).

Post facto Administrative Approval is hereby accorded to the "Construction of road from Rajouri to Baba Ghulam Shah Badshah (BGSB) University" Length 8.00 Kms (7.00 Kms Flexible + 1.00 Kms Rigid Pavement) at an estimated cost of Rs 31.52 Crore under Languishing Projects Programme (LUP1943) funded through JKIDFC.

The Administrative Approval is subject to the fulfillment of following conditions:-

1. *The work shall be executed after observing all Codal /procedural formalities strictly in accordance with the standing norms/orders/guidelines/instructions issued by the Government from time to time.*
2. *The work shall be executed/designed as per latest relevant I.S. Codes and specifications of MoRTH/PWD Engineering Manual 2020/CPWD and as per J&K Works Manual. The same are authenticated and proof checked by the competent authority (NIT/DIQC) before taking up execution in hand.*
3. *Rates for the items, not covered in JK SSR or any other relevant schedule, shall conform to Analysis of rates based on authentic Data Book, to be computed and approved by the competent authority well before invitation of tenders in accordance with set codal procedures.*
4. *That the work shall be completed within the AA to the utmost satisfaction of the indenting Department and the expenditure shall be incurred strictly as per AA/Technical sanction accorded by the competent authority. No liability whatsoever shall be allowed/entertained.*
5. *That the lump-sum provisions, either in terms of percentage or fixed, as made for certain components of each DPR are provisional and shall be subject to detailed estimates based on actual details/requirements and relevant rates, to*

be framed and approved by competent authorities well before invitation of tenders in accordance with set codal procedures.

6. That the work shall be completed in all respects within the specified time frame as indicated in the DPR. No cost overrun/escalation shall be entertained and no deviation shall be made in the drawings/designs/specifications of the work without prior approval of the competent authority.
7. That the working BOQs, based on approved design details/requirements, are framed as per J&K PWD schedule of rates for e-tendering purpose of the project.
8. The detailed estimate of works shall be technically sanctioned by the competent authority.
9. It must be ensured that there shall be no multisource of funding or overlapping of schemes under different programmes.
10. E-tendering mode is followed for fixation of the award of contract for execution of the projects. Fragmentation of project, while tendering, is not allowed.

The expenditure on this account shall be debit able to relevant account head.
