Whereas, the Chief Engineer, PW(R&B), Jammu vide letter No. CEJ/Estab./S/2293-95 dated 27.12.2021 has forwarded the case of Shri Retesh Sharma, Draftsman (Civil), for acceptance of his Diploma in Civil Engineering and inclusion of his name in the seniority list of diploma holder Draftsman (Civil) whose particulars are given below:-

Whereas, the case was examined in the department and Diploma along with marks certificates of the official were forwarded to the concerned Board on 10.02.2022 for verification/authentication of genuineness of the Diploma acquired by the said Draftsman (Civil). In response, the Principal, Pathankote Polytechnic College, Pathankote vide their letter 2022/ PTK/ PPC/ 1104 dated 24.02.2022 has verified that all documents are genuine and correct and these are issued by the Punjab State Board of Technical Education and Industrial Training, Chandigarh.

Whereas, the above named Draftsman has also produced undertaking in the shape of Affidavit affirming therein that the contents of the affidavit are true and correct to best of his knowledge and belief, if proved false, he shall be personally responsible for the same.

Whereas, the case was again examined in the department and it has been observed that there is a case to accept the Diploma acquired by above named incumbent and include his name at appropriate place in the relevant seniority list of Draftsman (Civil) diploma holders as and when the same is notified afresh.

Whereas, a notice was issued vide endorsement No. PWD- HRM1/3/2022-05 dated 25.05.2022 for inviting therein objections from the members of the cadre who are likely to be affected due to decision of the department. In response, the Chief

Engineer R&B Department, Jammu vide his letter dated 03.08.2022 followed by his No.CEJ/Estab./S/868-70 dated 05.12.2022 has stated that his office has not received any objection from any person till date after issuance/publication of the notice.

Whereas, the case has been re-examined in the department and it has been decided to accept the Diploma certificate acquired by the above named official, treat him as Diploma holder Draftsman (Civil) and include his name at appropriate place in the relevant seniority list of Diploma Holder Draftsman (Civil) as and when the same is notified by the department.

Now therefore, Shri Retesh Sharma, Draftsman (Civil) shall henceforth be treated as Diploma holder Draftsman (Civil) and subsequently his name shall be included at appropriate place in the relevant seniority list of Diploma Holder Draftsman (Civil) as and when the same is notified afresh by the Administrative Department.
