Subject: Final seniority list of the Degree Holder Junior Engineers (Civil) of the Jammu and Kashmir Engineering (Subordinate) Service of the Public Works (R&B) Department as on 31.12.2020

**Government Order No. 47-PW(R&B) of 2025,
Dated: 12.02.2025**

WHEREAS, the Final Seniority of Degree Holder Junior Engineers (Civil) was notified vide Government Order No 460-PW(R&B) of 2019 dated 22.10.2019 and has been operated upon for placements/ promotion of Degree Holder, Junior Engineer (Civil) as Assistant Engineers (Civil);

AND WHEREAS, the process of revision of the ibid seniority has been undertaken by the Department owing to the following reasons:-

(i) Final Seniority of Degree Holder Junior Engineers (Civil), has not been revised/ updated since 22.10.2019, which otherwise is mandatory in terms of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956 and advisories issued by the General Administration Department on the subject from time to time;

(ii) A considerable number of members of the service figuring in the ibid seniority have already been promoted to higher post(s), with some having retired on attaining of age of superannuation, and as such their names need to be deleted from the ibid seniority of Junior Engineers;

(iii) Some of the members figuring in the final seniority have been allocated / apportioned to Union territory of Ladakh by the General Administration Department vide Government Order No. 1212-JK(GAD) of 2021 dated 15.11.2021, followed with more such orders, and are to be deleted from the seniority list;

(iv) After issuance of the final seniority on 22.10.2019, a number of issues/ claims have been put forth by members of the service for consideration under the relevant rules given that a few direct recruits

have not been assigned seniority as per their merit obtained in the selection process conducted by the Jammu and Kashmir Service Selection Board and also in whose case the withheld recommendations have been released by the recruiting agency later on;

(v) A number of claims have been received in the Department from in-service Diploma-holder Junior Engineers, having been subsequently treated as degree holders on attainment of degrees through proper channel and those promoted as Junior Engineers from Draftsman, Works Supervisors, Shift Attendant, Field Workers, Field Supervisors category and having acquired degrees through proper channel for fixation of seniority in light of the provisions of the Jammu and Kashmir Engineering (Subordinate) Service Recruitment Rules, 1997;

(vi) Some of the members figuring in the final seniority who have either left the jobs or their appointment has been cancelled for various reasons; a few Diploma Holders figuring in the seniority; Junior Engineers appointed under Hon'ble PM Package for Kashmiri Migrants are required to be deleted from the seniority of Degree Holder, Junior Engineers(Civil); and

(vii) A number of Diploma Holder Junior Engineers (in-service) who have attained higher qualification through proper permission have not been given a place in the existing final seniority and need to be included as per the general principle of having seniority position in the Degree Holder Quota as per the provisions existing in the Recruitment Rules.

AND WHEREAS, a tentative a seniority of the Degree Holder Junior Engineers (Civil) was issued in the form of 'Notification' vide No. PWD-HRM2/36/2021[59221] dated 03.01.2025, for inviting objections from the members of service/ stake-holders, providing them opportunity to submit their grievances along with relevant documents, for further consideration under rules;

AND WHEREAS, for ensuring that all the members of service eligible for consideration for inclusion in the seniority are provided suitable opportunity for submitting their objections, if any, through the prescribed mode, the tentative seniority list of the Degree Holder Junior Engineer (Civil), issued vide notification No. PWD-HRM2/36/2021[59221] dated 03.01.2025, was given wide publicity through electronic and print media. The notification was hosted on the official website of the Department (<https://www.jkpwdrb.nic.in>) and was also published in the leading daily news papers namely; *The Kashmir Despatch* & *The Daily Aftab*, at Srinagar on **08.01.2025** and *The Daily Excelsior* & *The Amar Ujala*, at Jammu, on **10.01.2025**;

AND WHEREAS, the tentative seniority list notified on 03.01.2025, comprised of Annexures as per the following break-up/categorization:-

AND WHEREAS, the objections/ representations, against the ibid tentative seniority, were invited through a dedicated email [shuaibalig.kas@jk.gov.in] and Central Receipt Unit at Civil Secretariat, Jammu /Srinagar, with last date of submission fixed on 17.01.2025;

AND WHEREAS, a total of **231** (two hundred and thirty one) objections/ representations, have been received in the Department, with the following break-up:

AND WHEREAS, after examination of the objections/ representations, it was found that 49 were repeats, submitted by the members/ stakeholders, both through email and CRU, while as 6 were anonymous. As such, '**176 objections/**

representations have been received, including those received upto the final date of consideration, which are to be examined on merits;

AND WHEREAS, as a matter of principle, the seniority of a Government employee is to be determined in terms of Rule-24 of the Jammu and Kashmir Civil Services (Classification, Control and Appeal) Rules, 1956. However, in respect of the Junior Engineers, who have initially been appointed as Diploma Holders or those promoted as such from Draftsmen, Works Supervisors, Shift Attendants, Field Workers and Field Supervisors category, but have subsequently acquired Degree in relevant branch of engineering with proper permission from the Government, the seniority has also to be determined with reference to Note-2 mentioned under 'Category-A' of Schedule II-A (Executive) of the Jammu & Kashmir Engineering (Subordinate) Service Recruitment Rules, 1997, which provides as under:

"A Junior Engineer Grade-II Diploma Holder after acquiring AMIE Section (A&B), shall be treated as Degree Holder for the purpose of seniority from the date of completion/passing of AMIE Section (A&B) course."

AND WHEREAS, the above provision in the Jammu & Kashmir Engineering (Subordinate) Service Recruitment Rules, 1997, makes it amply clear that such diploma holder Junior Engineers and officials belonging to other eligible categories from feeding cadre, who have acquired the degrees with proper permission and have later on been treated as degree holders, are to be treated as degree holders from the dates of completion/passing of the degrees. However, on perusal of such Government Orders relating to acceptance of degrees of members, it has come to fore that in some of the orders of acceptance, it has clearly been mentioned that such members shall be treated as degree holders from the date of completion/passing of degrees, but in respect of some other cases, no express mention has been made in this regard despite the member having completed the degree from a date prior to the date of issuance of such Government Order of acceptance. As a matter of rule, all such members shall have to be treated as degree holders from the date of completion/passing of the degree;

AND WHEREAS, one of the members, who was figuring in the Final Seniority List of Degree Holder (Civil), Junior Engineers, notified vide Government Order No 460-PW(R&B) of 2019 dated 22.10.2019, at serial No. 870, has filed an O.A bearing No.15/2025, titled 'Sajad Hussain Vs Public Works (R&B) Department', before the Hon'ble Central Administrative Tribunal, Jammu, wherein he has prayed for protection of his seniority position and consequential benefits granted to him and the

Hon'ble Tribunal vide its Order dated 17.01.2025, has passed following directions in the matter:-

"5. In the meanwhile, the respondents are directed not to disturb the present status/ position of the applicant as on date till the next date of hearing."

AND WHEREAS, in compliance of the above directions of the Hon'ble Central Administrative Tribunal, the seniority position of Er. Sajad Hussain (applicant in O.A/15/2025) has been kept undisturbed in relation to his immediate senior in Government Order No 460-PW(R&B) of 2019 dated 22.10.2019, and shall be subject to outcome of final disposal of the O.A/15/2025, titled 'Sajad Hussain Vs Public Works (R&B) Department', by the Hon'ble Tribunal;

AND WHEREAS, the objections/representations received in relation to the tentative seniority list, have been examined for consideration on merits and have been disposed of, having regard to Rule 24 of the J&K Civil Services (Classification, Control and Appeal) Rules, 1956 and the provisions contained in the Jammu and Kashmir Engineering (Subordinate) Service Recruitment Rules, 1997. The details of disposal objections/ representations received are given in "**Annexure-B**" of this Order;

AND WHEREAS, having regard to the disposal of the objections/ representations received on the subject and on further examination, following facts have emerged:-

- (i) Fourteen (14) Engineers, out of the seventeen (17) engineers figuring in 'Annexure-B' of the Tentative Seniority List, have submitted the records/ documents and have substantiated their claim for inclusion in the final seniority list of Degree Holder (Civil), Junior Engineers;
 - (ii) Ten (10) Engineers out of the sixty (60) engineers figuring in 'Annexure-C', of the Tentative Seniority List, have submitted the records, substantiating their claim to be eligible for inclusion in the final seniority list of Degree Holder (Civil), Junior Engineers;
 - (iii) Out of the Engineers figuring in the remaining 'Annexures [D, E & F]' of the Tentative Seniority List, none from Annexure-D, only one (1) from 'Annexure-E' and three (3) from 'Annexure-F', have submitted the relevant documents for making out their cases for inclusion in the final seniority list of Degree Holder (Civil), Junior Engineers;

(iv) Further, some of the Engineers, who neither figure in the Final Seniority list of Degree Holder (Civil), Junior Engineers, issued vide Government Order No. 460-PW(R&B) of 2019 dated 22.10.2019, nor in the Tentative Seniority List notified on 03.01.2025 and whose Degrees have been accepted by the Department from time to time from the dates of passing of Degrees acquired through proper channel, have represented for consideration for inclusion of their names in the final seniority list of Degree Holder (Civil), Junior Engineers;

(v) The direct recruits who were figuring in the Final Seniority of Degree Holder (Civil), Junior Engineers, issued vide Government Order No. 460-PW(R&B) of 2019 dated 22.10.2019, and also in the Tentative Seniority List notified on 03.01.2025, but their seniority was not assigned as per their inter-se merit secured in the selection process, have made out their cases with submission of documentary proof for consideration of assignment of seniority positions at appropriate places, as per the governing rules/ regulations.

(vi) The Junior Engineers figuring at Sr. No. 41, 55, 466, 572, 595, 601, 618, 645, 658, 666, 668, 694, 712, 766, 777, 804, 835, 860, 869, 870, 875, 877, 885, 894, 905 and 910 of the proposed Final Seniority list, who have been appointed in continuation of the appointment order issued in respect of their counterparts figuring in the same selection list, after release of their withheld recommendations subsequently by the Jammu and Kashmir Service Selection Board and who had superior merit in the selection process, shall have to be considered for assignment of notional seniority from the date of appointment of their counterparts in the main selection based on the inter-se merit secured in the selection process.

NOW, THEREFORE, the seniority list of the Degree Holder (Civil), Junior Engineers, members of the Jammu and Kashmir Engineering (Subordinate) Service of the Public Works (R&B) Department, appointed/ promoted upto 31.12.2020, forming "**Annexure A**" to this Order, is hereby notified for information of all the concerned members. This shall be without prejudice to the outcome of the writ petition(s), pending, if any, in competent court(s) of law. The dates of birth of members recorded in the seniority list shall in no manner be construed as final and shall be subject to verification from service-book/date of birth certificates of the concerned engineers. Further, the reserved category / selection category recorded

against some members, shall not be taken as final at the time of consideration for placement / promotion on higher posts and shall be subject to production of genuine / valid reserved category certificates at the relevant point of time, issued by the competent authority.




