Whereas, on the recommendations of the Services Selection Board, J&K conveyed vide No. SSB/Secy/Sel/Class-IV/2021/6273-78 dated 18.10.2022 duly endorsed by the General Administration Department's O.M. No. GAD/MTGRBIV/267/2022-09-GAD dated 27.10.2022, among others, Mr. Suhail Ahmad Taploo S/o Gh Mohammad Taploo was appointed as Class-IV (MTS) vide Government Order No. 405-PW(R&B) of 2022 dated 18.11.2022; and

Whereas, vide Government order No. 405-PW(R&B) of 2022 dated 18.11.2022, the services of Mr. Suhail Ahmad Taploo, MTS were placed at the disposal of the Chief Engineer, PW(R&B) Department Kashmir for further posting, who has joined there on 06.12.2022; and

Whereas, the Chief Engineer, PW(R&B) Department, Kashmir vide his office order No. CE/PWD(R&B) K-199 (ADM) of 2022 dated 17.12.2022 further posted Mr. Suhail Ahmad Taploo (MTS) in (R&B) Division Ganderbal and subsequently, consequent upon the Re-organization/Restructure of PW(R&B) Department, he was transferred and posted to PWD(R&B) Circle Ganderbal vide Chief Engineer, PW(R&B) Department Kashmir's Office order No. CE/PWD(R&B) K-138 (ADM) of 2023 dated 06.10.2023; and

Whereas, subsequent to his appointment/joining, the Chief Engineer, PW(R&B) Kashmir vide his letter No. CE/R&B/CK/ADM/1380-81 dated 11.11.2023 has informed that Mr. Suhail Ahmad Taploo, MTS has tendered his resignation from the post of Class-IV (MTS) through the medium of an application dated 11.10.2023; and

Whereas, the Chief Engineer, PW(R&B) Department, Kashmir forwarded his request to the Public Works (R&B) Department for acceptance of his resignation as the said candidate has been selected as Junior Pharmacist in the Health and Medical Education Department vide Government Order No. 754-AH of 2023 dated 11.10.2023 figuring at Sl.No. (8) and;

Whereas, the matter has been examined/considered with reference to the rules governing the subject and it has been observed that the concerned official is still on probation and has not qualified the prescribed probation period of service; and

Whereas, Rule 21(1) of J&K Civil Services (Classification, Control & Appeal), Rules, 1956, provides as under:-

"At any time before the expiry of prescribed period of probation the appointing authority may:

- a) Suspend the probation of a probationer and discharge him from the service for want of vacancy; and
- b) At its discretion terminate the probation of a probationer and discharge him from the service"

Now, therefore, in exercise of the powers conferred under Rule 22(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by Mr. Suhail Ahmad Taploo (MTS) is hereby accepted and is discharged from the Government service with effect from the date, the applicant submitted resignation i.e. 11.10.2023 on his own request.
