The DDO's concerned shall operate the funds at placed at their disposal under Major Head: 2059-Public Works, 2211-Housing, 4059-COOP, 5054-Captial (Outlay), 2055-Police, 2071-PORB , 3054-R&B, 8009-GP Fund, 8011-SLI, 8443-Civil Deposit & remittance thereof. The DDO concerned shall also operate funds placed at their disposal on BEAMS of works of other departments placed by the competent authority under relevant head of account:

The DDO Powers are subject to the fulfillment of following conditions.

1. The DDO shall operate on the treasury to the extent of funds placed at his disposal by the Competent Authority.
2. That all the codal formalities are to be fulfilled while incurring the expenditure.
3. That no excess over allotment/irregular expenditure is made by the DDO.
4. That the concerned DDO shall ensure submission of the Accounts to the different quarters in time and maintain record as prescribed in General Financial Rules, 2017/Manuals.
5. That the DDO shall submit the monthly/quarterly, Receipt/Expenditure statements to the Administrative Department through their controlling officers.
