Whereas, on the recommendation of the Services Selection Board, J&K conveyed vide No. JKSSB-PLAN/25/2023-03 dated 03.03.2023 & No. JKSSB-PLAN/25/2021-03 (E-7069680) dated 07.07.2023, among others, Shri Nehal Devogtra S/o Reghuvir Chander was appointed as Junior Assistant vide Government Order No. 457-PW(R&B) of 2023 dated 08.11.2023 and his services were placed at the disposal of Chief Engineer, PMGSY (JKRRDA) Jammu; and

Whereas, subsequent to his appointment, the appointee was directed to report to the Chief Engineer, PMGSY (JKRRDA) Jammu within a period of 21 days from the date of issuance of appointment order failing which the appointment shall be deemed to have been cancelled ab-initio without any notice; and

Whereas, Shri Nehal Devogtra S/o Reghuvir Chander has failed to join/report to the office of the Chief Engineer, PMGSY (JKRRDA) Jammu within stipulated time as per report furnished by the Chief Engineer, PMGSY (JKRRDA) Jammu vide his communication No. CEJ/PMGSY/19459 dated 30.11.2023; and

Whereas, as per circular No. 08-JK(GAD) of 2019 dated 04.12.2019 under endorsement No. GAD(SER)Genl/Circ/06/01 dated 04.12.2019 issued by the General Administration Department, it has been provided that the candidates who fail to join with a period of 21 days from the date of issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.

Now, therefore keeping in view of aforementioned report furnished by the Chief Engineer, PMGSY (JKRRDA) Jammu in the matter, it is ordered that the appointment of Mr. Nehal Dovegotra S/o Reghuvir Chander (under Social Caste Category) as Junior Assistant in the Public Works (R&B) Department pursuant to Government Order No. 457-PW(R&B) of 2023 dated 08.11.2023 is hereby cancelled ab-initio having been failed to join within the stipulated period.
