Subject: Acceptance of resignation tendered by Umer Rafiq Bhat (MTS).

Whereas, on the recommendation of the Services Selection Board, J&K conveyed vide No. SSB/Secy/Sel/Class-IV/2021/7103-11 dated 18.10.2021 duly endorsed by the General Administration Department vide O.M. No. GAD/MTGRBIV/63/2021-09-GAD dated 19.10.2021, among others, Mr. Umer Rafiq Bhat S/o Mohd Rafiq Bhat was appointed as Class-IV (MTS) vide Government Order No. 327-PW(R&B) of 2021 dated 23.10.2021; and

Whereas, vide Government Order No. 327-PW(R&B) of 2021 dated 23.10.2021, the services of Mr. Umer Rafiq Bhat S/o Mohd Rafiq Bhat were placed at the disposal of Chief Engineer, PW(R&B) Department, Kashmir for further posting; and

Whereas, the Chief Engineer, PW(R&B) Department, Kashmir vide his office order No. K-118 (ADM) of 2021 dated 17.11.2021 further posted Mr. Umer Rafiq Bhat S/o Mohd Rafiq Bhat (MTS) in R&B Division Vailoo with nomenclature of posts "Road Worker"; and

Whereas, subsequent to his appointment/joining, the Superintending Engineer (R&B) Circle Anantnag duly endorsed by the Chief Engineer, South Kashmir vide his letter No. CE/R&B/SK/ADM/40-42 dated 19.10.2023 has informed that Umer Rafiq Bhat, MTS has tendered his resignation from Government service through an application on 15.09.2023 with the reasons that he has been appointed as Assistant Engineer in Mechanical Engineering Department vide Government Order No. 380-PW(R&B) of 2023 dated 14.09.2023; and

Whereas, the matter has been examined/considered with reference to the rules governing the subject and it has been observed that the concerned official is still on probation and has not qualified the prescribed probation period of service; and

Whereas, Rule 21(1) of J&K Civil Services (Classification, Control & Appeal), Rules, 1956, provides as under:-

At any time before the expiry of prescribed period of probation the appointing authority may:

- a) suspend the probation of a probationer and discharge him from the service for want of vacancy; and
b) at its discretion terminate the probation of a probationer and discharge him from the service."

Now, therefore, in exercise of the powers conferred under Rule 21 (1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the resignation tendered by Mr. Umer Rafiq Bhat S/o Mohd Rafiq Bhat (MTS) is hereby accepted and is discharged from the Government service with effect from the date, the applicant submitted resignation i.e. 15.09.2023 on his own request.
