Sanction is hereby accorded to the release and advance drawal of funds by the Director Finance PW(R&B) Department to the tune of Rs.99,46,72,236/- (Rupees Ninety nine Crore forty six lakh seventy two thousand two hundred thirty six only) received from MoRD, Government of India as grant-in-aid to the UT of J&K under PMGSY as Central assistance, released by the Finance Department vide U.O No.56438-FD/Res0/16/2021-03-FD/459 dated: 23.02.2024 for its crediting into SNA Account of JKRRDA.

The funds so authorized are subject to the following conditions: -

- i. Funds are to be used on for the purpose for which these are released.
- ii. Director Finance of the Department shall vouchsafe the availability of funds under relevant head of account.
- iii. All codal formalities are fulfilled.
- iv. Advance payment if any be made, shall be adequately secured and properly guaranteed before the release of actual payment.
- v. The Technical sanction/administrative approval shall be obtained prior for undertaking the said work from the competent authority.
- vi. The expenditure shall be incurred strictly as per the guidelines of the scheme and conditions laid down in the sanctioned letter of the concerned Ministry, Govt. of India. The Expenditure on this account shall be debited to the detailed account head given as under: -
