Subject:- Acceptance of Degree acquired by Mr.Naveed Ahmed Bhat, Works Supervisor (Civil) and inclusion of his name in the relevant seniority list.

Whereas, the Chief Engineer, PW(R&B), Jammu vide his letter No. CEJ/Estab./S/2617-19 dated 03.03.2021 has forwarded the case of Mr. Naveed Ahmed Bhat, Works Supervisor (Civil) whose particulars are given below for acceptance of his Degree in Civil Engineering and inclusion of his name in the relevant seniority list of Degree holders Works Supervisors (Civil) of PW(R&B) Department:-

Whereas, the case was examined in this department and Degree/ marks certificates of the above named official were forwarded to the concerned University vide this department's letter No. PWD-HRM1/19/2021-05 dated 21.06.2021 for verification/ authentication of genuineness. In response, the Assistant Registrar (Certificate Section) Kurukshetra University, Kurukshetra vide their letter No.A R(CS)/CS-I&II/21/916P dated 01.09.2021 has verified the genuineness of Degree acquired by Mr. Naveed Ahmad Bhat under Roll No./Regd. No. 2212959/13-SDB-197.

Whereas, on re-examining of the case, it was observed that Mr.Naveed Ahmed Bhat was appointed as Works Supervisor (Civil) on 24.05.2017 and passed/acquired Degree in B.Tech on 30.06.2018. As such, the Chief Engineer, PW(R&B) Jammu, was requested vide this department's letters dated 22.09.2021 and 17.02.2022 to clarify as to how the official attended classes w.e.f 24.05.2017 onwards and obtained said degree in regular mode.

Whereas, in response, the Chief Engineer, PW(R&B) Department Jammu vide his letter No. CEJ/Estab./S/1073-75 dated 25.08.2022 has intimated that the official had completed his degree during June, 2016 under Roll No. 2212959 & Reg. No. 13-SDB-197 from Kurukshetra University, Kurukshetra, but the University had issued

Degree to the Official on 30.06.2018, besides, the official had completed his degree prior to his appointment.

Whereas, the above named Works Supervisor has also produced undertaking to the effect that in case any information about his degree is found fraudulent/bogus at any time during service, his degree shall be deemed to be cancelled ab-initio and action as warranted under rules shall be initiated against him in terms of J&K Civil Service (Classification, Control and Appeal) Rules 1956.

Whereas, on re-examining of the case in the department, it has been observed that there is a case to accept the Degree acquired by the above named official from the date of passing and include his name at appropriate place in the relevant seniority list of Degree holders Works Supervisors (Civil) as and when the same is notified by the department afresh.

Whereas, the case was further examined in the department and a notice was issued vide No. PWD- HRM1/162/2022-05 dated 25.11.2022 for inviting therein objections from the members of the cadre who are likely to be affected due to decision of the department. In response, the Chief Engineer, PW(R&B), Jammu vide his letter No. CEJ/Estab./S/1780-82 dated 11.01.2023 has intimated that his office has not received any objection/s from any person till date after issuance/ publication of the notice in the Newspapers.

Now therefore, Mr. Naveed Ahmed Bhat, Works Supervisor (Civil) shall henceforth be treated as Degree holder Works Supervisor (Civil) from the date of passing Degree and subsequently his name shall be included at appropriate place in the relevant seniority list of Degree holders Works Supervisor (Civil) as and when the same is notified afresh by the department.
