Subject:- Acceptance of Degree acquired by Sunny Sharma, Draftsman (Civil) and inclusion of his name in the relevant seniority list of Degree holders Draftsman (Civil).

Whereas, the Chief Engineer, R&B Jammu vide his letter No.CEJ/ Estab/ S/3513-15 dated 08.03.2022 and letter No.CEJ/ Estab./ S/ 246-48 dated 09.05.2022 has forwarded the case of Mr. Sunny Sharma, Draftsman (Civil) for acceptance of his Degree and inclusion of his name in the seniority list of Degree Holders Draftsman (Civil) of PW(R&B) Department. The particulars of said Draftsman (Civil) are given as under:-

Whereas, the case was examined in the department and the copies of Degree/ marks certificates (all semesters) of the said official were forwarded to the Controller of Examination, ARNI University, Kathgarh Indore, Himachal Pradesh vide this department's letter dated 27.05.2022 for verification/ genuineness of Degree acquired by the official. In response the ARNI University vide their letter dated 27.07.2022 has verified/ confirmed that Sh.Sunny Sharma has completed Bachelor of Technology (Civil Engineering) vide Registration No. AAC10053A/10 in the year 2014 and also confirmed that they provide education only through regular mode at University campus for all the academic programs.

Whereas, the above incumbent has also produced undertakings in the shape of affidavit affirming therein that he is working as Draftsman in R&B and further declares that in case any information about his degree/certificates/Marks card is found bogus/false at any time, his service, his degree shall be deemed to be cancelled ab-initio and action under law or action as warranted under rules and shall be taken against him in light of J&K civil Services (classification Control and Appeal) rules-1956

Whereas, on re-examining of the case it has been observed that there is a case to accept his Degree and include his name at appropriate place in the relevant seniority list of Degree Holders Draftsman (Civil) of PW(R&B) Department as and when the same is notified afresh by the department.

Whereas, the case was further examined in the department and a notice was issued on 17.11.2022 for inviting therein objections from the members of the cadre who are likely to be affected due to decision of the department. In response, the Chief Engineer PW(R&B) Jammu vide his letter No. CEJ/Estab./S/1852-53 dated 18.01.2023 has intimated that his office has not received any objection/s from any person till date after issuance/ publication of the notice in the Newspaper.

Now, therefore, Sh.Sunny Sharma, Draftsman (Civil) shall henceforth be treated as Degree holder Draftsman (Civil) and his name shall be included at appropriate place in the relevant seniority list of Degree Holders Draftsman (Civil) of PW(R&B) Department from the date of appointment as and when the same is notified afresh by the department.
