Whereas, the following retired engineers approached this department for their regularization as Executive Engineers (Mechanical); and

1. Er. K.K Wangnoo, retd, Executive Engineer (Mech) Degree holder.
2. Er. G. S Bali, retd, Executive Engineer (Mech) Degree holder.
3. Er. Ashok Kumar Verma, retd, Executive Engineer (Mech) Degree holder.
4. Er. Mubarak Ahmad Mir, retd, Executive Engineer (Mech) Degree holder.

Whereas, the cases of the said engineers was examined in the department and it was found that these Engineers have not been regularized as Executive Engineers(Mechanical) as the seniority of Assistant Executive Engineers(Mech) has not been fixed/issued in their favour; and

Whereas, the relevant seniority lists of Assistant Executive Engineers (Mechanical) have been issued vide Government Order No. 105-PW (R&B) of 2005 dated: 29.03.2005 and vide Government Order No. 279-PW (R&B) of 2022 dated: 18.08.2022; and

Whereas, Er. Mubarak Ahmad Mir, has been regularized as Assistant Executive Engineer (Mechanical) vide G.O 361-PW(R&B) of 2023 dated: 30.08.2023 w.e.f. 01.06.2005; and


