WHEREAS, on the recommendations of the Services Selection Board, Mr. Talib Hussain Mir was appointed as Multitasking Staff (MTS) vide Govt Order No. 337-PW(R&B) of 2021 Dated 03.11.2021 and his service were placed at the disposal of Chief Engineer, North Kashmir;
