**Government Order No. 69-PW(R&B) of 2025,
Dated: 25.02.2025**

WHEREAS, on the recommendations of the Services Selection Board, J&K, among others, Mr. Danish Amin Wani was appointed as Junior Engineer vide Government Order No. 61-PW(R&B) of 2024 dated 07.03.2024 and was placed at the disposal of Chief Engineer, PW(R&B) Department, South Kashmir;

AND WHEREAS, the Chief Engineer, South Kashmir vide ibid referred communications has forwarded the resignation cases of Mr. Danish Amin Wani, Junior Engineer for acceptance by the competent authority, on the grounds that he has been selected as Junior Engineer in the Jal Shaki Department;

AND WHEREAS, the matter has been examined/considered with reference to the rules governing the subject and it has been observed that the concerned official is still on probation and has not qualified prescribed probation period of service;

AND WHEREAS, Rule 21(1) of J&K Civil Services (Classification, Control & Appeal), Rules, 1956, governs of probation in the Government service and provides as under:-

At any time before the expiry of prescribed period of probation the appointing authority may:

- a. Suspend the probation of a probationer and discharge him from the service for want of vacancy; and
- b. At its discretion terminated the probation of a probationer and discharge him from the service."

NOW THEREFORE, in terms of Rule 21(1) (b) of the J&K Civil Services (Classification, Control & Appeal) Rules, 1956, the probation of Mr. Danish Amin Wani, Junior Engineer, is hereby terminated and is discharged from the Government Service w.e.f. 16.12.2024 on his own request.
