Subject: Re-organization/Restructuring of Public Works (R&B) Department-Transfer of posts thereof.

Whereas vide Government order No.22-JK(GAD) of 2023 dated 06.01.2023, Public Works (R&B) Department was reorganized/ restructured with merging/subsuming of engineering wings of 10 other departments including engineering wing of SKIMS, Soura; and

Whereas, 35 No of posts of Mechanical and Hospital Division SKIMS, of different categories have been kept in the central pool at the time of ree-organization; and

Whereas, 2 No of posts of Manifold Attendants are not mentioned in the re-organized structure of the department which are vital for mechanical wing and incumbent have been given the assignment of operation of Oxygen Plants for which they have been engaged; and

Now therefore, in view of the above and for the purpose of drawl of salaries of these employees, sanction hereby accorded to:
