- III) That funds should be utilized as per SDRF Items and norms of assistance/guidance, besides following all the required formalities as envisaged in GFR-17. The Utilization Certificate be furnished as per the form 12 of GFR- 17.
- IV) The expenditure should be incurred for the approved items without any deviations for which funds are released.

V) Advance drawl for Rs 78.05 Crore (Rupees Seventy Eight Crore Five lakhs) only is also accorded for procurement of snow clearance machine by Mechanical Engineering Department, J&K.


